

## ENROLMENT POLICY

### INTRODUCTION

**Catholic College Wodonga** is a registered **secondary** Catholic School which operates with the consent of the Bishop of the Catholic Diocese of Sandhurst and is owned and operated by Catholic Education Sandhurst (CES) Limited, where formation and education are based on the principles of Catholic doctrine, and where the teachers are outstanding in true doctrine and uprightness of life.

Our Catholic identity is the heart of our school and how we, as a community express and live our Catholic faith. Catholic education is intrinsic to the mission of the Church. It is one means by which the Church fulfils its role in assisting people to discover and embrace the fullness of life in Christ. Catholic schools offer a broad, comprehensive curriculum imbued with an authentic Catholic understanding of Christ and his teaching, as well as a lived appreciation of membership of the Catholic Church. Parents and guardians, as the first educators of their children, enter into a partnership with the Catholic school to promote and support their child's education. Parents and guardians must assume a responsibility for maintaining this partnership by supporting the school in furthering the spiritual and academic life of their children.

## PURPOSE

This policy sets out requirements for enrolment of domestic students at **Catholic College Wodonga**

## ENROLMENT PRINCIPLES

**Catholic College Wodonga** welcomes enrolments from families of all faiths and non-religious backgrounds. Where enrolment interests exceed the number of placements available, **Catholic College Wodonga** will give priority to enrolment of Catholic children as outlined in the **Enrolment Priority Criteria** approved by the Board.

Families who enrol their children at **Catholic College Wodonga** do so on the understanding that they respect and agree to support the Catholic identity, ethos and mission of the school and acknowledge the importance of religious education for their children.

**Catholic College Wodonga** wants to make every effort to ensure Catholic education is accessible to every Catholic family through the provision of family-friendly fee payments and relief.

**Catholic College Wodonga** strives to accommodate children with diverse needs. In cases where a child requires significant adjustments in order for an enrolment to be possible, **Catholic College Wodonga** will consider its obligations arising from Disability Standards and related legislation; what is in the best interest of the child and whether the school can reasonably be expected to make the required adjustments to assist the child to take part in education courses and programs, on the same basis as a child without disability.

Enrolment is subject to the maximum capacity of **Catholic College Wodonga**. For those students not able to be offered enrolment, **Catholic College Wodonga** will support their families in finding enrolment with another Catholic school.

## ENROLMENT REQUIREMENTS

It is expected that students seeking enrolment will normally reside in the designated parish or the agreed area that **Catholic College Wodonga** serves. Students may be accepted for enrolment outside their parish or agreed area, which the school serves if there are demonstrable circumstances which significantly disadvantage the student and/or family should the enrolment not occur or if Insert school name meets their needs more appropriately than the student's designated parish school.

You are required to provide particular information about your child during the enrolment process, both at the provisional application stage and if the school offers your child a place. Please note that lodgement of the enrolment form does not guarantee enrolment at the school. If the information requested is not provided, **Catholic College Wodonga** may not be able to enrol your child.

**Catholic College Wodonga** require the following documents from parents/guardians for enrolment purposes:

1. evidence of the child's Australian citizenship or permanent residency or eligible visa details
2. birth certificate of the child
3. immunisation records and other health records
4. court orders, custody arrangements relating to the child
5. previous school reports
6. any documentation relating to specific medical, health, intellectual conditions that will trigger the need for the school to provide reasonable adjustments to the learning environment or as required to meet additional enrolment criteria for enrolment

## Fees

School fees, fee schedules and payment options are outlined in the Catholic College Wodonga Fees document published on the school website. The fees must be paid for a child to enrol and to continue enrolment at the **Catholic College Wodonga**. The school has discretion whether to allow a child to participate in optional or extracurricular school events, such as paid school excursions or extracurricular activities, while fees remain due and payable.

In accordance with **CES Limited's School Fee Policy**, any family facing genuine financial hardship should in the first instance speak with the Principal. Families facing hardships are encouraged to apply for a fee concession. This includes those families who hold a Health Care Card (HCC) eligible for Camps, Sports and Excursion Funds (CSEF). An application for a fee concession should be made to **Catholic College Wodonga** and all information provided will be treated in the strictest of confidence.

## ENROLMENT REGISTER

In accordance with requirements of the Education and Training Reform Regulations 2017 (ETR Regulations), **Catholic College Wodonga** maintains a register of enrolments that contains at minimum the following information in relation to each student enrolled at the school:

1. The student's name, age and address
2. The name and contact details of any parent or guardian of the student
3. The date of enrolment of the student
4. The Victorian Student Number allocated to the student
5. The date that the student ceases to be enrolled at the school

This information is collected and stored in the College Administration system which is Synergetic.

The information collected during the process of enrolment will be stored, maintained and shared in accordance with the *Privacy Act 1988 (Cth.)*. A copy of the enrolment information will also be maintained in each student profile.

## ENROLMENT REGISTER PROCEDURES

**Catholic College Wodonga** collects enrolment data at the point of enrolling a new student. For all existing students, the school undertakes a process of confirming enrolment data, including health information and emergency contact information. The process of confirming enrolments typically occurs at the end of an academic year. It is the responsibility of the parents/guardians to inform the school of any changes to the enrolment information as soon as practicable. It is the responsibility of the Admissions and Activities Officer to maintain enrolment information in the register in accordance with this Policy and procedures.
